

# TERMS AND CONDITIONS REFERRAL PROGRAMME

- 1. Promotional Offer: Refer an eligible (as per 3b below) new business to OakNorth Business Banking and get a £300 charity donation (after deduction of any applicable Tax) which will be split equally between the Referrer and Referee —OakNorth will donate £150 on behalf of the Referrer, and £150 on behalf of the Referee, to charities of their choice (subject to charities due diligence).
